# Delegation of Power of Attorney for Sale of Hames

Know ye that I, the undersigned, fully empower and permit Rabbi Ya'aqob Menashe to act in my place and stead, and in my behalf to sell all HAMES possessed by me (knowingly or unknowingly) as defined by the Torah and Rabbinic Law (eg. Hameş, doubt of Hameş and all kinds of Hameş mixtures). Also Hameş that tends to harden and to adhere to a surface of inside of pans, pots or cooking and usable utensils, and all kinds of live animals that have been eating Hameş or mixtures thereof. And to lease all places wherein the Hameş owned by me may be found, especially in the premises located at \_\_\_\_\_, and elsewhere.

Rabbi Menashe has the full right to sell and to lease by transactions, as he deems fit and proper and for such time which he believes necessary in accordance with all detailed terms and detailed forms as explained in the general authorization contract which have been given this year to Rabbi Menashe to sell or effect the sale of the Hameş.

This general authorization is made a part of this agreement. Also do I hereby give the said Rabbi Menashe full power to appoint a substitute in his stead with full powers to sell and to lease as provided herein. The above given power is in conformation with all Torah, Rabbinical regulations and laws, and also in accordance with the laws of the State of New York and of the United States.
